Applications under the **Tuition Fee Waiver (TFW) Scheme** are invited from eligible students admitted during the **Academic Session 2026-27** to:

- ICD programmes
- B.E. programmes (LEET and JEE)

Following are main features of the TFW Scheme:

1. The **Tuition Fee Waiver (TFW)** shall be granted on the basis of merit.
2. The **TFW Scheme** is applicable to the sons and daughters of parents (both father and mother) whose **combined annual income from all sources is less than ₹8 lakh**.
3. The **TFW Scheme** is limited to the Tuition fee only. All other fees, except the Tuition fee, shall be payable by the beneficiary student.
4. A beneficiary student admitted under the **TFW Scheme** shall not be permitted to change their **Trade/Branch** under any circumstances.
5. Students are required to submit an **Income Certificate of both parents (father and mother)** issued by the Competent Authority. The Income Certificate must have been issued **on or after 1 April 2026**.

The eligible students should submit their applications in the prescribed proforma, available from the SET Office, along with the required supporting documents. The last date for submission of the application, duly completed in all respects and in the prescribed proforma, is **15 September 2026**.

Note: The Undertaking (printed on the reverse side of the TFW application form) is mandatory for all students.
